Restated here is the note from the minutes of the 2021 AGM which provides background on reducing the level of administration. Context for and update on decisions taken by the Committee to streamline the operation of	 RSGS has 29 trophies played for in 5 events plus knockouts We have approximately 50 active members with up to 20 playing in each event Our committee spends hundreds of hours per year organising events, recording information on our website, and doing administrative tasks including preparing reports for the AGM 2 issues have led us to consider revising RSGS's operating model The amount of effort put in to running the Society is disproportionate for the number of members Finding members willing to commit to doing the work of running the Society has proved difficult for the past several years We feel that maintaining RSGS's traditions and having great golf and social experiences at our events does not require the current level of administration. We intend to make some changes this year, and to consider further changes in the coming years We will reduce the number of trophies played for and simplify competition administration e.g. we will move to stableford format only Move to a single membership sub of £50 per year We will keep our Webcollect members and competition signup system but replace the public rsgsgolf.com website with a simple public website for static information and marketing. We will no longer update that website with e.g. competition results, match reports, and photographs
